LIABILITY WAIVER & HOLD HARMLESS AGREEMENT

This Liability Waiver and Hold Harmless Agreement ("Agreement") is made effective as of the date of use of the yachtingwithchristos.com website ("Website") by the user ("User") and is entered into by and between Charter Brokerage Yachting with Christos LLC ("Yachting with Christos"), and the User.

WHEREAS, Yachting with Christos acts as a charter broker and presents vessels that are available for rent on the Website; and
WHEREAS, the User desires to use the Website and potentially rent a vessel presented on the Website;

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Yachting with Christos and User agree as follows:

1. **Assumption of Risk.** The User understands that the use of a rented vessel involves inherent risks, including but not limited to the risks of personal injury, death, and property damage. The User voluntarily assumes all such risks.
2. **Release and Waiver of Liability.** The User releases and waives any and all claims, demands, causes of action, suits, or judgments against Yachting with Christos, and its officers, directors, employees, agents, and affiliates, arising from or in any way connected with the use of a vessel rented through the Website, including but not limited to any injuries, damages, or losses suffered by the User or any third party.
3. **Indemnification.** The User agrees to indemnify, defend, and hold harmless Yachting with Christos, and its officers, directors, employees, agents, and affiliates, from and against any and all claims, demands, causes of action, suits, or judgments, including reasonable attorneys' fees and costs, arising from or in any way connected with the use of a vessel rented through the Website by the User, including but not limited to any injuries, damages, or losses suffered by the User or any third party.
4. **No Responsibility for Vessel or Crew.** The User understands that Yachting with Christos is a charter broker and does not own, operate, or control the vessels presented on the Website, nor does it employ or control the crew onboard any rented vessel. Yachting with Christos is not responsible for the condition, safety, or seaworthiness of any vessel presented on the Website, or for the actions or omissions of any crew member onboard any rented vessel.
5. **Governing Law and Jurisdiction.** This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware, without giving effect to its principles of conflicts of law. Any dispute arising under or in connection with this Agreement shall be resolved exclusively in the state or federal courts located in Delaware.
6. **Entire Agreement.** This Agreement constitutes the entire agreement between Yachting with Christos and the User and supersedes all prior or contemporaneous negotiations, discussions, or agreements, whether written or oral.
7. **Severability.** If any provision of this Agreement is found to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.
8. **Acknowledgment of Understanding.** The User has read this Agreement, understands its terms, and agrees to be bound by them.
